I. Argument

Defendants-Appellees Matthew Katzer and Kamind Associaties, Inc. (Katzer) oppose *Amicus Curiae*'s (Amicus) motion for leave to file a brief in support of Appellant.

Fed. R. App. Pro. 29(e) directs the filing of an amicus brief "no later than 7 days after the principal brief of the party being supported is filed." Amicus seeks to file a brief in support of Appellant. Appellant's principle brief was filed with this Court on June 1, 2009. Amicus certify that they filed their brief with this Court on June 15, 2009, one week late.

Amicus's motion fails to make any showing of good cause why this Court should extend the time period to accept a late-filed brief as required by Fed. R. App. Pro. 26(b). See 1998 Advisory Committee Notes to FRAP 29(e) (applying the good cause showing requirement to FRAP 29(e)).

Amicus's motion prejudices Katzer as any time spent responding to Amicus cuts into his limited time to respond to Appellant's principle brief.
